## The Birding Community Says Thank You!

On the afternoon of February 1st, Elsie Fisher sighted a Pyrrhuloxia near her home at Anthony City Lake, just north of the town of Anthony. She notified Eddie Stegall who posted a note on the Kansas Birds Listserv (KSBIIRD-L).

Several birders trekked to Anthony City Lake on Friday, February 2nd, were able to relocate the bird and photograph it. By late February the bird was still being seen and Elsie reports that she knows of over 75 birders that have seen the bird.

Pyrrhuloxias are not a common species in Kansas. This is only the 8th Kansas record. The last time this species was seen in Kansas was in 2000. A report has been filed with the Kansas Bird Records Committee along with a plethora of photographs.

Kansas birding really is a community. Thanks to the consideration of Elsie, who notified other birders, word of the sighting spread rapidly and many birders were able to see the bird and add it to their state or life lists. Thanks to the generosity of the Kansas Birding Community, a photo of the bird taken by David Seibel was framed and presented to Elsie as a gift of appreciation from the entire Kansas Birding Community. From all Kansas, and neighboring states, birders, thank you Elsie!

# Kansas Birding Roundup, Fall 2017, (August – November) Chuck Otte, compiler

---

This is the report of the fall birding season in Kansas, August through November. Fall is a time of transition. The breeding season is wrapping up and already, by early August, southbound migration is in full swing. By the time the season ends, migration is pretty well wrapped up. But every year, we find ourselves struggling with what's an early record, what's a late record and how much is climate change impacting this?

Merlins and Sharp-shinned Hawks started showing up earlier than most long time bird observers expect. Fall departure of summering species and arrival of migrants or wintering species, like these raptors, is strongly correlated to north winds and colder weather. Over the last several years we have found many lingering species, especially when it comes to shorebirds. 2017 continued that trend with many species staying weeks later than normal. Several species that appeared in the summer season lingered, most notably Black-bellied Whistling-Ducks, and their young, as well as Quivira's Reddish Egret. Roseate Spoonbills were reported from two locations with one staying for nearly a month.

Few birds represent the enigma of birding better than the Snowy Owl. When Snowy Owls show up in Kansas they attract attention, A lot of attention. The winter of 2011-12 was a record setting irruption year. Since then we've had none to a few per winter. In the two biggest irruption years the first Snowy Owls showed up on or very near November 15<sup>th</sup>. The Snowy Owl that showed up near Perry Lake on November 16<sup>th</sup> set birders scrambling and hearts pounding. Would this be another big irruption year? Check back in the next Roundup for the answer to that question!

Many finch species are well known nomads. They may be absent from the state for two or three years and then suddenly appear in large numbers all across the state. Pine Siskins started showing up in August, and while not reported below, by early fall they were widespread and common. Red Crossbills started appearing in early August putting birders across the state on high alert. The reports came pouring in on a daily basis. August and September reports are reported below but by the time we got to October they were showing up everywhere, eventually being tallied in over 30 counties in the state. When possible, birders were recording their calls and submitting them to eBird for analysis. Type 2 was the most common subspecies reported with occasional reports of Type 4 being recorded. Fall warblers are expected and often common, although ID can be a challenge. A Painted Redstart is not one of those difficult to ID species. The seventh Kansas Painted Redstart record was seen and photographed at Lee Richardson Zoo in October. Some warblers are early migrants, some are late and some just never know when to leave. As with shorebirds, southbound warblers often hang around as long as weather and food allow. Some species, other than Yellow-rumped Warblers, occasionally overwinter. Again because of an extended late fall, several species lingered far later than normal causing us to not mention them this year when other years their appearance would be noteworthy. Lingering species deserving a mention because of the lateness or number include Northern Parula, Wilson's Warbler and Orange-crowned Warbler. I'm sure that 50 years from now researchers will be able to look back on these records and make some intriguing correlations with climate change.

I am occasionally asked how a decision is made on what to include in this Roundup. It comes down to location and date. A Whooping Crane at Cheyenne Bottoms or Quivira in November is not very noteworthy. But one in eastern Kansas at the same time would be noteworthy. I rely heavily on the range maps in *Birds of Kansas* (Thompson, et. al., 2011) as well as early and late dates from that book, modified with records since then. Then an adjustment is made for what was being seen in each season. A sighting one year might be worth reporting, but the next year it might not. Anyone wanting to view those date tables should contact me, or for ranges, check the range maps in *Birds of Kansas*.

Any report marked as having been turned in to the Kansas Bird Records Committee (KBRC) should be considered tentative until review by the Committee is completed. Thank you to everyone who reports and contributes sightings for this report. ## Two New Species Added to the KOS Checklist

The Kansas Bird Records Committee (KBRC) met in early February to finalize action on records submitted in 2017 and to update the review list. Everyone who submitted records in 2017 has been notified of the decisions on their records. The full report, as per tradition, will be printed in the June KOS Bulletin.

Kansas lost a species in 2017 due to the lumping of Thayer's Gull with Iceland .That dropped the all-time Kansas species count down to 478. HOWEVER, the KBRC accepted a record of **Brown Booby** (based on a photo of one perched on a wind turbine that was taken by a wind turbine technician). After much debate the KBRC also accepted, as a hypothetical species, **Little Stint**, based on exceedingly detailed notes and drawings submitted by the observer. Hypothetical species are those species that have been convincingly documented but for which we fail to have some sort of physical evidence, i.e. photo, video, audio or a specimen. There are only 13 hypothetical species on the KOS Checklist. The addition of these two species raised the all-time Kansas species count to 480. The KBRC also removed a few species from the Review List including: Iceland Gull, Black-legged Kittiwake, Little Gull and Lesser Goldfinch based on number of records. Also removed from the review list was Eskimo Curlew due to the high likelihood that this species is now extinct. The meeting was called to order at 9:42 a.m. by President Nic Allen.

Attendance: Nic Allen, Henry Armknecht, Matt Gearheart, Kevin Groeneweg, Dan Larson, Terry Mannell, Cheryl Miller, Chuck Otte, Max Thompson, and Eugene Young. Rodney Wright had planned to be present but had become ill on Friday. Patty was traveling.

**Minutes:** The Secretary handed out copies of the minutes of the Annual Meeting and Board Meeting held at the Annual Meeting in October 2017. These had also been sent out via email prior to the meeting. **Max moved to approve the minutes as presented. The motion was seconded by Matt and passed 10 – 0.**

**Treasurer's Report:** Max handed out copies of the Balance Sheet and financial transactions for the past year. Total income from all sources in 2017 was \$9,196.70. Total expenses for the period were \$9,688.74. A substantial amount of the income is from meeting registrations so most of that goes back out to pay the expenses of the meeting. The other principle expense is printing and mailing of the *Bulletin* and *Horned Lark*. In 2017 that expense was \$4,421.75. Sales of *Birds of Kansas* have slowed, but we still received a royalty check for 2017 of a little over \$350. This money goes into the Book Royalty Fund. The investment fund had done very well in 2017. Max said that the new book, *Birds of Missouri* is in final editing and will be out soon. It will primarily be available for sale as an eBook. If someone wants a printed copy it will be printed and bound on demand. **Terry moved to accept the Treasurer's Report and file it for audit. The motion was seconded and passed 10 – 0.**

**Vice President:** Cheryl reported that she had been in touch with Jeff and planning for the spring meeting is progressing.

**Membership:** Patty was currently out of the country but will send a membership report to the board when she returns.

**Bulletin Editor:** The September issue had been delayed because there was nothing to publish. A manuscript had been received, reviewed, and accepted for publishing and the September issue was now at the printer being typeset. A manuscript had been received for the December issue and had been accepted for publication with some revisions but wasn't ready in time for the mailing. The March 2018 issue, the Christmas Bird Count issue, is in process. It is a lengthy process to get it typeset and proofed. There was a discussion of the issue of no manuscripts. Many of the presented papers from the fall meeting would be excellent papers if the presenters would simply submit them. It was suggested that Gene and Chuck write up something explaining the help that would be available to anyone who wants to author an article for the *Bulletin*. This could be printed in the *Horned Lark* as well as being posted on the KSBIRD-L listserv and on Facebook. **Max moved to accept the report of the Bulletin editor. The motion was seconded and passed 10 - 0.**

**Horned Lark Editor:** Chuck said that the December issue was at the printer being printed and was waiting for a Bulletin or two to go with it. Target date for the March issue was to be at the printers by mid-March so it can be in member's hands a month before the spring meeting. Chuck announced that we needed to start getting someone lined up to take over the KSBIRDS web page as he wanted to hand it off in 3 or 4 years. Several members commented that the web page could use an update. Chuck indicated he agreed and that it would need to be done by others with more web skill than he has.

The discussion then moved into the social media aspects of the KOS Facebook page and how can we get more information on that page and hopefully create interest in people to learn more about birds and hopefully join KOS. There are a lot of people interested in bird photography right now that may or may not have any interest in becoming birders. There was additional extensive discussion of the social media challenge and how it seems to divide people and organizations, not bring them together.

**Business Manager:** Dan informed the board that in the past year he had had 110 products produced and 68 have been sold. 34 were sold at meetings and 34 at the gift shop at the Wetlands Education Center at Cheyenne Bottoms. Dan led a discussion on possible future items to produce and sell. He felt that it might be a good idea to slash prices on existing stock, then when the next items are ordered limit the amount and market them as very limited edition and try to get them sold out quickly. It was suggested to see if the gift shop at the Baker Wetlands would be interested in carrying any items. American Kestrel and Northern Shoveler were suggested for clothing and perhaps it was time to bring back something with the Horned Lark on it. Chuck encouraged Dan to get information to him to get on the web page and in the Horned Lark.

#### **Committee Reports:**

**Scholarship/Research Committee** – Max reported on behalf of the committee formerly known as the Student Research Fund committee. Following action by the KOS Board in October, a payment of \$675 to the Kansas Biological Survey Endowment Fund was pending to help sponsor additional surveying of plants, lichens and mosses at the Dingus Natural Area. Two requests for funds had been received, 1 from Ft. Hays State and one from Emporia State. One was very well done and the other was somewhat weak. As the deadline for applications is February 15th, the selection committee had taken no action yet.

There was no report from the Conservation Committee.

**Kansas Bird Records Committee (KBRC):** Gene reported that the KBRC would be meeting in the afternoon. The terms of Chuck Otte and Jon King were expiring. Chuck was willing to serve a second term; Jon had declined to serve a second term. Following election of the board members they will also need to elect a secretary as that position expires when Chuck's board term expires. As the board members have to be approved by the KOS Board, an email will be sent out for board approval in the near future.

#### **Unfinished Business:**

**KBBAT** – Chuck discussed that he had been in discussion with KDWPT personnel about trying to get this arranged and moving forward. The big hurdle right now is getting funding so we can use eBird as a portal for all data entry. Attempts to find professors willing to lead or co-lead this, as well as capable lay people have hit a series of dead ends. Chuck feels we need to keep moving forward on this and he will be in contact with KDWPT in the near future.

**Research Fund Auction** – At the fall meeting a motion was passed authorizing the president to appoint a committee to find a way to reactivate this fundraiser in some manner. It was suggested to get a handful of very nice items and have a raffle/drawing. Nic said that he would like names of interested KOS members be sent to him and he will name a committee soon.

#### **New Business:**

**Spring Meeting 2018** – Cheryl and Chuck have been in contact with Jeff. Jeff is working on details and should have things lined out fairly soon.

**Fall Meeting 2018** – While it is planned that we will be in Lawrence for the 70<sup>th</sup> Anniversary of KOS we don't really have a local committee yet. Cheryl and the board will continue to work on this.

**Bylaws** – Cheryl and Chuck had found a few more lingering phrases in the bylaws that were not gender neutral. In addition there were several items in the bylaws that needed updating to reflect changing technology as well as reflecting the way that the society is operating today.

**Gene moved that the following changes be proposed to the bylaws for the membership to vote on at the annual meeting in the fall. The motion was seconded by Terry and the motion passed. The proposed changes are:**

**Article V. Section 3A: Remove “Librarian” and “Publicity” and insert “Electronic and Media Coordinator”.**

**Article V. Section 3B: Replace “Librarian” with “Electronic and Media Coordinator.” This is in two different locations in 3B.**

**Article VI. Section 2C: Remove “Publicity” and replace “his” with “their”.**

**Article VI. Section 2E: Replace “Librarian” with “Electronic and Media Coordinator.”**

**Article VI. Section 2: Add “L. Prepare and be authorized to sign all legal agreements with individuals and organizations.”**

**Article VI. Section 3A: Replace the first instance of “his” with “their” and replace the second instance of “his” with “the President’s”.**

**Article VI. Section 5. Remove 5C. Then change D. to C., E. to D. F. to E. Change 5G. to 5F. and add “and oversee distribution of *The Bulletin* and the Newsletter.**

**Article VI. Section 7. Remove items B. C. E. and F. Change 5. D. to B. and Change 5. G. to C.**

**Article VI. Section 8. C. Change to read: “Publish *The Bulletin* and the Newsletter quarterly if material and funds permit.”**

**Article VI. Section 8. Add section E. “Oversee the printing of *The Bulletin*, Newsletter and other publications.”**

**Article VI. Section 9. Replace “Librarian” with “Electronic and Media Coordinator”.**

**Article VI. Section 9. Replace all of A. with “Be responsible for seeing that the web page is kept up to date. This will include, but not be limited to posting back issues of *The Bulletin* and the Newsletter on a schedule agreed upon with the KOS Board, maintaining historical records on the website, working with the secretary to archive historical records, and other items as determined by the KOS Board.”**

**Article VI. Section 9. Replace all of B. with “Be responsible for keeping relevant information on the KOS Facebook page.”**

**Article VI. Section 9. Add: “C. Work with the local committee of each spring and fall meeting, the editor of the newsletter, and appropriate media contacts, to coordinate publicity of upcoming meetings, events and announcements of interest.”**

**Article VI. Section 12. Remove this section.**

**Article VI. Section 13. – Renumber to Section 12.**

**Article VI. Section 14. – Renumber to Section 13**

**Article VI. Section 15. – Renumber to Section 14.**

**There being no further business, Nic adjourned the meeting at 11:50 a.m.**
