Rules of the KOS Official Records Committee

I. NAME

The name of this committee is the Official Records Committee, hereafter referred to as "the committee".

II. DUTIES

A. Functions of the committee

1. To solicit, organize and maintain records, documentation, photographs, tape recordings, etc. of the birds of Kansas. Two duplicate sets of records will be maintained; one by the chairperson, and one deposited in the Museum of Natural History, University of Kansas, Lawrence, KS.
2. To review reports of species - new or rare in the state - and provide final judgment of their status. Maintain an official Kansas list. Judgments of the committee with editorial comments will be provided in an annual report at the fall meeting of the Society. A single official list will be maintained with the following information annotated for every species:
 - a. (1) Specimen available
(2) Photograph (accepted by the committee)
(3) Sight Record (accepted by the committee)
 - b. Number of species in each of the above categories listed, as possible.
 - c. Breeding status past or present in Kansas.
 - d. List of species on which information is needed and what specific information is needed.
3. Disseminate information through the KOS Bulletin or Newsletter to assist KOS members in developing knowledge and skills.

- B. The purpose of the committee is to serve the professional and amateur KOS member and to promote and help maintain a high degree of quality, integrity and professionalism. For the committee to function, it needs the complete support of all interested persons in the state. Individuals should feel free to dispute in the open literature, the published opinions of the committee, and vice-versa.

III. MEETINGS

- A. Most committee work will be handled by correspondence with one meeting each year at the annual meeting of the society. Other meetings may be held as desired by the Chairperson.

IV. CIRCULATION OF RECORDS

- A. Records shall be circulated as received. Committee members should evaluate and judge the document and return with their comments to the chairperson within 30 days.

1. Whooping Cranes family (3 birds) with radio tagged young landed and spent night in Pawnee County, October 24, 1981. Two families with radio tagged young left nesting grounds September 15, 1982. Population about 130 to 140, Wood Buffalo Park - 94.

2. Peregrine Falcon, Barton County, October 1; Coffey Co., October 12; Riley County, December 19; Osage County, December 20; Saline County, December 20; Stanton County, fall; Pawnee County, January 13; Scott County, May 10, roadkill.
3. Bald Eagle, Winter Survey, January 8 and 9, 1982, recorded 472 wintering bald eagles - no county records for 14 counties - Barber, Bourbon, Brown, Greeley, Harper, Jackson, Kiowa, Sheridan, Smith, Stanton, Washington, Wichita, Wilson and Woodson.

Cornell University's Laboratory of Ornithology has begun publication of a new magazine devoted to the study of birds, The Living Bird Quarterly.

Color-illustrated and directed toward everyone with an interest in birds, the quarterly will feature articles and photographs on bird behavior, habitat, conservation, art and research, and will be international in scope. The first issue, for example, contains articles on the reproductive success of songbirds, the conservation efforts of the International Crane Foundation, the restoration to the Maine coast of the Atlantic puffin population, and a direct-from-life color painting and story by artist and author George Miksch Sutton.

In addition to articles written by professional writers and ornithologists, the laboratory will encourage amateur "birders" to contribute. This is part of the larger mission and tradition of the Laboratory of Ornithology--to act as liaison between the amateur and professional ornithologist and to encourage people's interest and increase their knowledge of living birds.

The quarterly, which began publication in July, will be sent to laboratory members and will replace its annual publication, The Living Bird.

The Laboratory of Ornithology is the only recognized institution of its kind in the world. It was founded in 1957 by eminent ornithologist and photographer Arthur A. Allen and pioneer bird sound recordist Peter Paul Kellogg.

October 2, 1982

The meeting of the Board of Directors of the Kansas Ornithological Society was called to order by President Charles Ely on Saturday, October 2, at 12:45 p.m. in the Education Building at the Sedgwick County Zoo.

MEETINGS: KOS was invited by John Parrish to meet at Emporia State University on October 1-2, 1983. Charles Ely announced that the spring 1983 meeting would probably be at Camp Horizon, southeast of Arkansas City, April 30-May 1.

AMENDMENTS TO BY-LAWS: The following proposed amendments, copies of which had been mailed to the membership, were considered by the Board:

1. Combining of Article II, sections 2 and 4 with regard to classes of membership and membership dues. Relettering remaining parts of section 4 as A to G.
2. Article II, new section 4F
Old by-law--article II, section 4M -- "Principal amounts received from Life Memberships shall be placed in an endowment fund and invested in securities approved by a majority vote of the Board of Directors with interest . . ."
Proposed by-law -- "Principal amounts received from Life Memberships shall be placed in an endowment fund and invested in securities approved by the Business Manager with interest . . ."
3. Article VI, section 6 -- add to the duties of the treasurer:
 - F. Be Resident Agent of the Society.
 - G. Prepare annual report for the Secretary of State on incorporation status.
4. Proposed Article VII. Special contribution and property.
 - Sec. 1. Contributions by bequests, memorials, gifts, etc., may be accepted anytime, such contributions to be used as designated by the donor upon approval by the Board of Directors.
 - Sec. 2. The donation of property may be accepted by the Society, by vote, upon recommendation of the Board, such property to be managed in its natural state for scientific or educational purposes, or to be managed or sold as a source of income for the Society.

Sec. 3. The specific uses to which the property is put shall be designated at the time of acceptance by the Society.

Sec. 4. Special funds may be established as needed to administer the contributions and their use in special projects and property management.

(Present articles VII through IX to be renumbered)

Discussion included the following suggestions: a. to delete "etc." from section 1 of the proposed article VII and replace it with "in the form of money." b. to allow the Board to accept property in section 2 of the proposed article VII rather than the Society. David Seibel moved that the above four amendments be recommended to the membership for adoption at the afternoon business session of the Society. Cal Cink seconded the motion. The motion passed.

ADDITIONAL AMENDMENTS TO THE BY-LAWS: Gene Lewis presented the following proposed amendments:

1. Article IV, section 5 -- add "such reports to be published in full or in resume in the Newsletter."
2. Article VI, section 2 -- delete "E. Be authorized to countersign checks." Reletter succeeding parts of section 2.
3. Article VI, section 4 -- delete "B. Keep an inventory of records and supplies belonging to KOS and shall distribute them to others as necessary."
Delete "C. Be authorized to countersign checks."
Relletter succeeding parts of section 4.
4. Article VI, section 5C -- change from "Advise the Editors of membership changes" to "Advise the Business Manager of membership changes."
5. Article VI, section 2 -- add "H. Be authorized to fill, until the next annual or special meeting, any vacancy on the Board of Directors."

Max Thompson moved that the above amendments be recommended to the membership for adoption at the afternoon business session of the Society. Cal Cink seconded the motion. The motion passed.

DINGUS NATURAL AREA: Gene Lewis reported that the telephone company had asked for permission to put in a cable along the south edge of the natural area. Permission was denied by the Society but the company went ahead and installed the cable. He and Max Thompson will seek just compensation.

The meeting adjourned.

KOS ANNUAL FALL MEETING 1982
Education Building, Sedgwick County Zoo
Wichita, Kansas
October 2-3, 1982

The thirty-fifth Annual Meeting of the Kansas Ornithological Society was held at the Sedgwick County Zoo in Wichita, Kansas, on October 2-3, 1982.

Saturday, October 2, Morning Session.

Steve Kingswood opened the meeting at 9:15 a.m. and introduced Mark Reed, Assistant Zoo Director. Mr. Reed welcomed the KOS to the Sedgwick County Zoo and described some of the zoo programs. Charles Ely, President of KOS, responded to this welcome and thanked the Sedgwick County Zoo for hosting the KOS meeting.

Steve Kingswood made some announcements in regard to local arrangements. Charles Ely then turned the meeting over to Cal Cink who chaired the morning paper session (see attached program). Because of a shortage of time, only the first six papers were presented and the paper by William J. Stark and Roger L. Boyd was moved to the afternoon session.

A business session was called to order by Charles Ely at 11:50 a.m. He asked all those in attendance to sign the attendance register. He announced that the Board of Directors would meet at 12:30 p.m. in the lobby of the Education Building.

MINUTES: The minutes of the Spring meeting had been published in the Newsletter and they were approved as published.

REPORT OF THE NOMINATING COMMITTEE: The report of the Nominating Committee, Jean Schulenberg (Chairman), Marvin Schwilling and James Ptacek, was made by Jean Schulenberg. The slate of officers presented was:

APPOINTMENTS: Charles Ely appointed Galen Pittman and Elmer Finck to an Auditing Committee and John Zimmerman and Allen Jahn to a Resolutions Committee.

TREASURER'S REPORT: Gene Lewis reported that general expenses were greater than income from dues last year. He reported that the balance in the KOS checking account was \$743 last year and \$711 this year. The Dingus Natural Area account has increased to \$2500 due to some gifts. The total balance of KOS assets in checking account, certificates of deposit and passbook savings is \$9300. (See attached report).

MEMBERSHIP SECRETARY'S REPORT: Charles Ely reported for Jane Herschberger who could not be present to present her report. As of October 1, there were 378 KOS members, including 48 fully or partially paid life members. (See attached report)

BULLETIN EDITOR'S REPORT: John Zimmerman reported that the Christmas Bird Count dates were December 18 to January 2 this year. He encouraged KOS members to participate in a CBC and to start new counts. He reported that more manuscripts are needed for the Bulletin.

ACCEPTANCE OF REPORTS: Cal Cink moved that the reports of officers and committees be accepted. The motion was seconded and passed.

ANNOUNCEMENTS: Steve Kingswood described the six planned field trips.

The morning business session adjourned at 12:10 p.m.

Saturday, October 2, Afternoon Session.

After lunch there were zoo tours at 1:00 p.m.

Cal Cink convened the afternoon session at 2:10 p.m. and introduced Roger Boyd who presented the first paper (carried over from the morning) and then chaired the afternoon paper session. (See attached program)

Charles Ely convened the afternoon business session at 4:45 p.m.

ANNOUNCEMENTS: Charles Ely announced that next year's Fall Meeting would be at Emporia State University on October 1-2 and the Spring Meeting would be at Camp Horizon, April 30-May 1.

AUDITING COMMITTEE REPORT: The Auditing Committee reported that the books were in order. A motion was made to accept the report. The motion was seconded and passed.

ELECTION OF OFFICERS AND DIRECTORS: Jean Schulenberg introduced Scott Seltman and Larry Herbert, new nominees for directors. Nominations were opened for officers and directors. Effie Edwards moved that the nominations be closed and the secretary be instructed to cast a unanimous ballot for the slate of nominees. The motion was seconded and passed.

AMENDMENTS TO THE BYLAWS: The following amendments were presented by Charles Ely:

1. Combining of Article II, sections 2 and 4 with regard to classes of membership dues. Relettering remaining parts of section 4 as A to G. Roger Boyd moved that this amendment be approved. Cal Cink seconded the motion. The motion passed.

2. Article II, new section 4F

Old by-law -- article II, section 4M -- "Principal amounts received from Life Memberships shall be placed in an endowment fund and invested in securities approved by a majority vote of the Board of Directors with interest . . . "

Proposed by-law -- "Principal amounts received from Life Memberships shall be placed in an endowment fund and invested in securities approved by the Business Manager with interest . . . "

Roger Boyd moved that this amendment be approved. Cal Cink seconded the motion. The motion passed.

3. Article VI, section 6 -- add to the duties of the treasurer:

F. Be Resident Agent of the Society.

G. Prepare annual report for the Secretary of State on incorporation status.

Max Thompson moved that this amendment be approved. Roger Boyd seconded the motion. The motion passed.

4. Proposed Article VII. Special contributions and property.

Sec. 1. Contributions by bequests, memorials, gifts, etc. may be accepted anytime, such contributions to be used as designated by the donor upon approval by the Board of Directors.

Sec. 2. The donation of property may be accepted by the Society, by vote, upon recommendation of the Board, such property to be managed or sold as a source of income for the Society.

Sec. 3. The specific uses to which the property is put shall be designated at the time of acceptance by the Society.

Sec. 4. Special funds may be established as needed to administer the contributions and their use in special projects and property management.

(Present articles VII through IX to be renumbered)

Cal Cink moved that this amendment be approved. Margaret Boyd seconded the motion. Gene Lewis moved to amend the proposal by deleting "etc." from section 1 and replacing it with the phrase "in the form of money." Effie Edwards seconded this amendment. The amendment passed. The amended motion passed.

ADDITIONAL AMENDMENTS TO THE BY-LAWS: Charles Ely introduced the following amendments to the by-laws and stated that they would need a 95% affirmative vote for approval since they had not been circulated to the membership prior to the meeting:

1. Article IV, section 5 -- add", such reports to be published in full or in resume in the Newsletter."

2. Article VI, section 2 -- delete "E. Be authorized to countersign checks." Reletter succeeding parts of section 2.

3. Article VI, section 4 -- delete "B. Keep an inventory of records and supplies belonging to KOS and shall distribute them to others as necessary."
delete "C. Be authorized to countersign checks."
Reletter succeeding Parts of section 4.
4. Article VI, section 5C -- change from "Advise the Editors of membership changes" to "Advise the Business Manager of membership changes."
5. Article VI, section 2 -- add "H. Be authorized to fill, until the next annual or special meeting, any vacancy on the Board of Directors."

Amelia Betts moved the approval of the above amendments. Gene Lewis seconded the motion. The motion passed, 28 affirmative, 0 negative.

DINGUS NATURAL AREA REPORT: Gene Lewis presented the Dingus Natural Area Committee report (See attached report).

Max Thompson moved that KOS approach Mrs. Wade about selling 2-3 acres in order to straighten the property line of the Dingus Natural Area and make fencing easier. Roger Boyd seconded the motion. The motion passed.

ANNOUNCEMENTS: Max Thompson urged all members to report address changes promptly since the return of mailings was a cost to the Society.

The afternoon business session adjourned.

Saturday, October 2, Evening Banquet.

The annual banquet was served in the Formal Dining Room of the Kansas Newman College Administration Building at 6:40 p.m. After the meal, Charles Ely welcomed new KOS members and thanked the local committee for a fine job of making arrangements for the meeting.

RESOLUTIONS COMMITTEE REPORT: John Zimmerman read the report of the Resolutions Committee (See attached report). The resolutions were adopted by acclamation.

LIFE MEMBERS: Charles Ely announced that there were two new life members, Jane Holland and George Neavoll. He presented a life membership pin to George Neavoll, but Jane Holland was not in attendance.

TEN BEST BIRDS OF THE YEAR: Marvin Schwilling reported on the ten best birds of the year (See attached report). The top ten birds (in order) were: Garganey Teal, Ruff, Red-throated Loon, Eared Grebe (nesting), Lesser Goldfinch, Black-bellied Whistling Ducks, Golden-winged Warbler, Pygmy Nuthatch, Swainsons Warbler and Anhinga. Max Thompson asked about the Magnificent Frigatebird seen at Meade State Park and Marvin stated that that record had been overlooked in the preparation of the list.

Max Thompson introduced George Neavoll, Editor of the Editorial Page of the Wichita Eagle, who gave a challenging talk on meeting the conservation issues of our time. The speech was followed by questions and discussion.

Steve Kingswood announced the field trips for Sunday morning.

The evening session adjourned.

Sunday, October 3, Field Trips.

Six field trips were held in Sedgwick, Cowley and Harvey Counties on Sunday morning. Participants met for lunch at the Pawnee Prairie Park at 12:30 p.m. A total of about 110 species of birds were reported at the compilation.

NEW WILDLIFE AREAS BILL GOES INTO EFFECT 1 MAY 1982

The Newsletter Editor received the following Kansas statute from Mr. Robert M. Vaughan of Wichita presenting changes and regulations governing wildlife areas. The Board of Directors of KOS have not had time to research this bill, but it appears that it could have serious consequences for birdwatchers using Cheyenne Bottoms and other state wildlife areas. This will be brought before the Board of Directors at the Winter Board Meeting in January, and by that time we should have more information concerning this regulation's implications.

"23-8-11. Wildlife areas; use restrictions. (a) Hunting, shooting, killing, taking, trapping, injuring, pursuing, molesting, or disturbing in any way any bird or animal on or within wildlife areas shall be prohibited, except areas or portions of areas as may be opened, during the legal open season or some part of it, to any of these activities by commission regulation or by posted notice. In the event the director deems it advisable or necessary to restrict the use of hunting equipment
